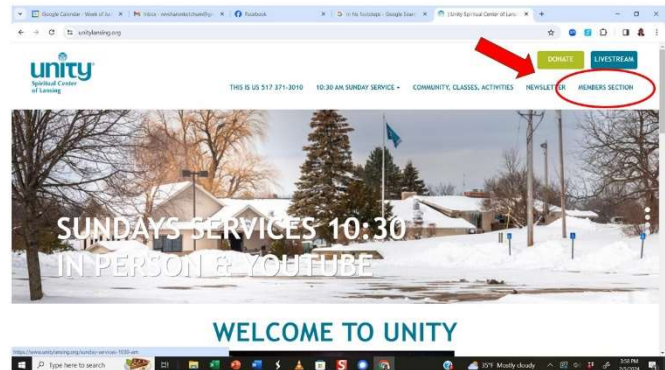
Dear member,
